Conditions of Use

www.ezittravel.com is owned by Changi Travel International Pte Ltd (CTI). Any reference in these Conditions of Use to “ezittravel”, “us or “we” shall refer to Ezi Travel Ltd. Any reference to “website” shall refer to www.ezittravel.com and to any auxiliary website supplementary to the main website.

CTI provides, through the Website, an interactive online service platform consisting of information services, content and transaction capabilities facilitated through us, our affiliates and/or merchants (“Merchants”) offering vouchers (“Vouchers”) for sale which may be exchanged for goods or services provided by Merchants. Vouchers may be made available for print or sent via SMS.

Please read these Conditions of Use carefully. By accessing and using the Website, you shall be deemed to agree and be legally bind by these Conditions of Use. If you do not accept these Conditions of Use, you should not access or use the Website.

1. Permission to use and access

- 1.1. We will permit you to access, use and interact with the website solely for your personal use, and be subject to these terms and conditions.
- 1.2. By accessing and using the website (whether with or without registering an account), you represent that you are at least 18 years of age and have the legal capacity to enter legally binding agreements.
- 1.3. We reserve the right to deny and/or restrict access to the website to any person at any time, or block access to the website from an internet IP address, without notice and without the need to prescribe any reason, therefore.

2. Your obligations

- 2.1. You shall use the website and the services provided therein for your own non-commercial, personal use, and for lawful purposes and in compliance with English law.

- 3.2.
